The Common Council of the City of Lafayette, Indiana met in regular session Monday, January 5, 2026 at 6:00pm. In the Common Council Chambers at 20. N 6th Street.

President Nargi called the meeting to order at 6:00pm

Election of officers

Councilmember Downing moved to nominate Councilmember Weast-Williamson as President of the Common Council for the year 2026, Councilmember Ahlersmeyer seconded. The motion passed by unanimous voice vote. Thereafter, Councilmember Weast-Williamson presided over the meeting. Councilmember Downing moved to nominate Councilmember Ahlersmeyer as President Pro-Tem for the year 2026, Councilmember Snyder seconded. The motion passed by unanimous voice vote.

Public Hearing

Councilmember Reynolds moved to recess for a public hearing on Resolution 2025-22 (A Resolution Declaring the Designation of Certain Real Estate as an Economic Revitalization Area (ERA) and Approving the Application for Property Tax Abatement) Councilmember Brown seconded. ORDINANCE 2026-01

2026 JAN 21 P 3:17 AN ORDINANCE ESTABLISHING

CINDY MURRAY **THE SOUTHEAST INDUSTRIAL TIF FUND #4750**

WHEREAS, the City of Lafayette (“City”) and Tippecanoe County (“County”) entered into a certain Joint Economic Development Agreement dated February 27, 2001, as amended (“Agreement”), relating to the sharing of tax increment revenues generated within the McCarty TIF Area and the Southeast Industrial TIF Area;

WHEREAS, the Agreement provides for the City and County to share tax increment revenues, and the parties have updated their accounting procedures to improve operational efficiency; and

WHEREAS, to implement those updated accounting procedures, the City desires to establish a separate fund dedicated to the receipt, tracking, and expenditure of the City’s portion of the tax increment revenues distributed from the Southeast Industrial TIF Area pursuant to the Agreement;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lafayette, Indiana, as follows:

Section 1. Establishment of Fund.

There is hereby established a special fund of the City known as the Southeast Industrial TIF Fund #4750 (“Fund”).

Section 2. Revenue Deposits.

The Fund shall consist of revenues received by the City representing the City’s share of the tax increment revenues distributed by Tippecanoe County from the Southeast Industrial TIF Area pursuant to the Agreement, as amended.

Section 3. Authorized Uses.

Money in the Fund may be used solely for purposes authorized under the Agreement, as amended, including the payment of costs and expenses eligible for payment from tax increment revenues in accordance with applicable law and the actions of the Lafayette Redevelopment Commission.

Section 4. Appropriation and Disbursement.

Expenditures from the Fund shall be made only pursuant to appropriation and approval as required by law and consistent with established claims and disbursement procedures of the City and the Lafayette Redevelopment Commission.

Section 5. Duration; Nonreverting Fund.

The Fund shall be a continuing (nonreverting) fund, and any unexpended balance remaining in the Fund at the end of the calendar year shall not revert, but shall remain in the Fund for the

purposes set forth in this Ordinance unless and until the Fund is terminated by subsequent ordinance of the Common Council.

Section 6. Effective Date.

The Ordinance shall be in full force and effect from and after its passage and approval by the Mayor, and publication, if any, as required by law.

ORDINANCE NO. 2026- 02

AN ORDINANCE TO AMEND ORDINANCE 2025-37, AN ORDINANCE FIXING THE SALARIES OF THE APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF LAFAYETTE, INDIANA, OTHER THAN SWORN PROTECTIVE OCCUPATION AND LAW ENFORCEMENT MEMBERS OF THE POLICE AND FIRE DEPARTMENT

WHEREAS , the Common Council of the City of Lafayette, Indiana, adopted the 2026 Salary Ordinance fixing the salaries of the appointed officers and employees of the City of Lafayette, Indiana, other than sworn protective occupation and law enforcement members of the Police and Fire Departments, and establishing the positions and classifications as set forth in Exhibit A, and pay scale as set forth in Exhibit B; and

WHEREAS , the Parks Department has identified a need to reorganize its administrative structure to better serve the community by replacing the Director of Operations/Projects (EXEC I) position with a new Outdoor Recreation and Athletics Coordinator (PAT III) position;

WHEREAS , the Parks Department and Police Department have further requested clerical updates to certain job titles to more accurately reflect the current duties and technical requirements of those roles; and

WHEREAS , the Human Resources Director and the Mayor recommend these adjustments to ensure departmental efficiency and proper classification of personnel;

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Lafayette, Indiana:

Section 1. Exhibit “A” of Ordinance 2025-37 is hereby amended as follows:

- In the Parks Department:
 - **Delete** the position “Director of Operations/Projects” (EXEC I).
 - **Add** the position of “Outdoor Recreation and Athletics Coordinator” (PAT III).
 - **Rename** the position of “Aquatics & Equipment Supervisor” (LTC IV) to “Maintenance Technician” (LTC IV).
- In the Police Department:
 - **Rename** the position “Uniform Division Technician” (PAT II) to “Administrative Assistant (PAT II).

Section 2. No other Changes.

All other terms and provisions of the 2026 Salary Ordinance, including Exhibit B and all other classifications, salary ranges, and positions not expressly amended by this Ordinance, shall remain in full force and effect.

Section 3. Effective Date

This Ordinance shall be effective upon passage and approval in accordance with law.
