At the conclusion of a four month investigation, the Tippecanoe County Drug Task Force arrested several subjects for Narcotic related charges. The Lafayette Police Department, West Lafayette Police Department, Tippecanoe County Sheriff's Department, Purdue Police Department and the Indiana State Police assisted with the arrests.
